# TOWN OF GIBRALTAR ORDINANCE NO. 1984-3

## PARKING LIMITATIONS AND RESTRICTIONS

The Town Board of Gibraltar does ordain as follows:

#### Sec. 1 PARKING LIMITATIONS AND RESTRICTIONS.

No. person shall operate a vehicle except in compliance with this ordinance on any street within the unincorporated Village of Fish Creek.

## Sec. 2 REGULATION OF THE VEHICLE.

- (a) No vehicle shall be operated on any street unless such vehicle meets the requirements of licensing, equipment and safety devices of appropriate regulatory agencies.
- (b) No vehicle shall be operated on any public property other than a street as herein defined.

#### Sec. 3 DEFINITIONS.

As used in this ordinance, the following words shall be defined as follows:

- (a) <u>Vehicle.</u> Any device in, upon or by which any person or property is or may be transported upon a street.
- (b) <u>Street.</u> Any public street, alley, road, thoroughfare, highway or other public place located in the Village of fish Creek, upon which vehicular traffic is normally contemplated.
- (c) <u>Person.</u> Any individual, firm, co-partnership or corporation.
- (d) <u>Operator</u>. Every individual who shall operate a vehicle as the owner thereof or as the agent, employee or permittee of the owner.
- (e) <u>Park.</u> To bring a vehicle to a stop, whether occupied or not, and keep standing at the edge of the street or to leave temporarily on a street or in a parking lot.
- (f) <u>Nonmoving Violation</u>. Any parking of a vehicle in violation of this ordinance.
- (g) <u>Traffic lane.</u> That part of the street, exclusive of parking spaces, upon which vehicular traffic moves.
- (h) <u>Marked Loading Zone.</u> That portion of the street used for the parking of vehicles but which is designated by signs as a loading zone.
- Sec. 4 LIMITATIONS AND RESTRUCTIONS ON PARKING IN TRAFFIC LANES AND PARKING LOTS.

- (a) All vehicles are forbidden to remain in a traffic lane except for the time necessary to unload or load passengers. A parking space will be provided for passenger buses on Bluff Spur Road.
- (b) Delivery vehicles may not park in a traffic lane while making deliveries except from a space designated by the Village of Fish Creek or from a Marked Loading Zone. All other deliveries shall be made from the rear of the shop, store, bar or restaurant.
- (c) No vehicle may be parked on any street or adjacent parking lot that has a sign reading "PARKING BY PERMIT ONLY", unless the vehicle has a Village Permit Sticker affixed to its windshield.

# Sec. 5 ISSUANCE OF NONMOVING VIOLATION CITATIONS.

(a) The Constable of the Village of Fish Creek shall issue a citation to owners or operators of illegally parked vehicles which shall inform the recipient of the citation as to the procedure for paying the penalty prescribed by this section and the consequences of not paying the penalty and which shall also note the following information.

- (1) An identification of the location of the space where the vehicle is illegally parked or street address.
- (2) The license plate number and state of issuance of the illegally parked vehicle.
- (3) The date and time at which the vehicle is observed to be illegally parked.
- (4) Any other facts that may be relevant to the issuance of the citation.

## Sec. 6 REMOVAL OF ILLEGALLY PARKED VEHICLES.

Constable of the Village of fish Creek finds a vehicle standing on a highway or other parking area owned, leased or controlled by the Village of Fish Creek in violation of any provision of this ordinance, he may remove such vehicle or require the operator thereof to move such vehicle to a position where parking is not prohibited. Expenses incurred by the constable in removing such vehicle shall be borne by the operator or owner of the vehicle, and shall be added to and become part of any forfeiture imposed.

## Sec. 7 PENALTY.

- (a) Unless otherwise specifically provided, the penalty for violation of any provision of this ordinance shall be a forfeiture as hereafter provided together with costs under 345.27, Wis. Stats.
- (b) Any person or persons violating any of the provisions of this ordinance shall be fined not less than five (\$5.00) dollars nor more than one hundred (\$100.00) dollars for each offense; and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

# Sec. 8 ENFORCEMENT PROCEDURE.

This chapter shall be enforced according to Secs. 66.12, 345.20 to 345.53 and Ch. 799, Wis. Stats.
