Dear Applicant:

The Fish Creek Harbor Commission made the following change in policy at the September 11, 2007 meeting.

- As of January 1, 2008 a deposit would be required for individuals on the slip and/or mooring waiting list.
- Slip deposit \$500
- Mooring deposit \$200
- Deposits will be refundable and held in a non-interest bearing account
- Deposits are one time only
- Annual reapplication is unnecessary; annually points will be added based on the latest application on file.
